The Los Angeles Housing Department (LAHD) is working with residential rental property owners and tenants to promote healthy and livable neighborhoods in the City of Los Angeles. The Los Angeles Housing Code (Article 1, Chapter XVI of the Los Angeles Municipal Code [LAMC]) requires LAHD to inspect residential rental properties under the Systematic Code Enforcement Program (SCEP).
